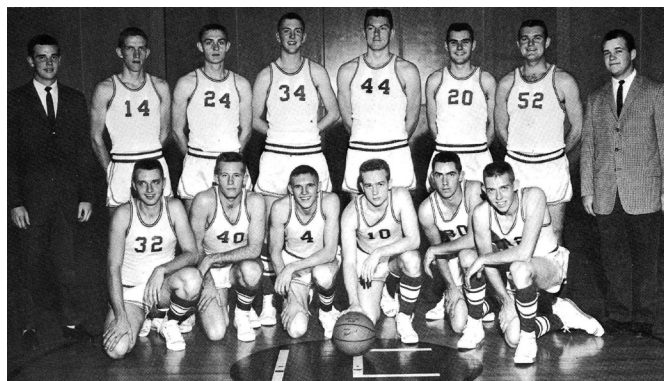

## A Message From the President



Greetings from Lincoln College! I hope your 2012 is off to a great start. Your ongoing connection to your alma mater is vital to the College's continued success, and I invite you to consider your association with the College and support it in any way you can.

Before recognizing the generosity of the many people who support Lincoln College, let me share with you some important initiatives underway on our two campuses.

### **Lincoln College Lincoln**

Significant progress is being made on moving the Abraham Lincoln Heritage Museum from its current quarters in McKinstry Library to the Lincoln Center. That move is scheduled to be completed in the spring of 2013. We are now determining the final look of the museum and its exhibits, while seeking enrichment funds for the project. A Friends of the Museum Committee has been formed to help with fundraising, while College staff pursue grant opportunities. The new museum will serve as an extraordinary resource not only for Lincoln College students and employees, but also for Lincoln fans and scholars across the globe.

Under the leadership of Dr. Dennis Campbell Lincoln College continues to develop the Environmental Education Center along Sugar Creek, approximately five miles north of campus. This project, which will strengthen the science program, is scheduled for completion in 2012.

The College just signed an agreement with St. Francis Medical Center College of Nursing in Peoria, Illinois, that

facilitates the transfer of Lincoln College associate's degree in science graduates to the bachelor's degree in the nursing program at St. Francis.

Last fall, the College began a dual-credit enrollment program with Lincoln Community High School to enable qualifying high school students to enroll in Lincoln College classes taught at the high school. Over 50 students enrolled last fall. The program represents an outstanding opportunity for high school students to get a head start on their college careers, and the College is now in discussions with Illini Central High School about implementing this program there next fall.

### **Lincoln College Normal**

You may be aware that the Normal campus offers several bachelor's degrees. Recently, the bachelor's degree in business administration received accreditation from the International Assembly for Collegiate Business Education. Congratulations to the faculty and staff of that campus for achieving this milestone.

### **Support of Lincoln College**

I continue to be impressed with the financial support provided to the College by both its alumni and friends. As difficult economic times continue in both higher education and the economy generally, such support is even more critical. It funds student scholarships, contributes to building projects, and undergirds important initiatives undertaken by the College. Without it, the College could simply not sustain the level of service and excellence it now provides. Let me offer my sincere thanks to donor alumni and friends of the institution. Your contributions are indispensable to the life of Lincoln College.

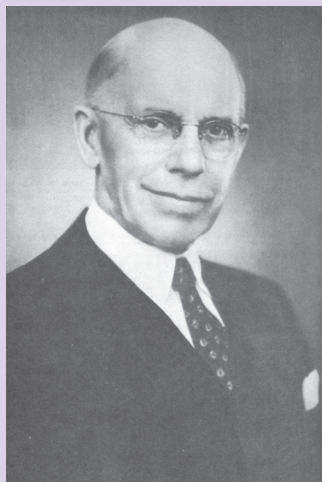

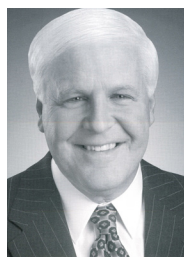

## Love of History Inspires Bequest

Who, or what, will be featured in my will as a beneficiary of my life's earnings in the wake of my death?

For Denny Frary, the answer to both queries was Lincoln College.

After selecting Lincoln College as his college choice as a high school senior in 1968, 43 years later, Frary chose LC again, this time as the recipient of a generous bequest in his will.

Frary's contribution has been designated to the Lincoln Heritage Museum. It's a fitting destination, considering his love of history is what drew him to Lincoln College in the first place.

"My brother was three years older and I can remember he would get mail from different colleges. I actually found out about Lincoln College from one of my brother's brochures," said Frary, a native of Prophetstown, Ill. "I was attracted to the history (of the school). It talked about the Hall of Presidents and obviously the connection with Abe Lincoln. I

started reading it. I learned that it was a place where I could get some individual attention. It was just a good place for me to start."

Choosing LC was a decision that Frary never regretted.

"It met all of my expectations. It was clear right away that I could talk to my instructors," said Frary. "It was a very cozy atmosphere."

As a student, Frary studied broadcasting and communication. He was also member of the men's golf team and enjoyed spending time with roommate Tom Gilbertson, whom he has kept in contact with since graduating from Lincoln College in 1970. Frary completed his bachelor's

degree from the University of Illinois at Urbana-Champaign. Museum, he may spark another young person's interest in history.

After college, Frary enjoyed a successful career, spending over 30 years as the chief meteorologist of KCRG-TV9 in Cedar Rapids, Iowa.

Because Lincoln College is smaller and more intimate when compared to other larger state schools, when asked what factors led to his decision to include Lincoln College in his will, Frary

said he felt his donation could make a more significant impact at Lincoln College than anywhere else.

"There comes a point in everyone's life where you have to start thinking about the future and what happens with what you have after you're gone," said Frary. "I knew I had family members that I wanted to do things for ... but I really saw (a bequest to Lincoln College) as an opportunity that might allow other young people to have the same experience that I had, that impacted my life for 40 years. It just seemed like a good and proper place to leave it."

Frary is especially hopeful that by donating to the Lincoln Heritage

I'd like to ensure, at least in a little way, that I helped Lincoln College and allowed other students to get a jumpstart to their life the way I did."

### Fine Arts Update

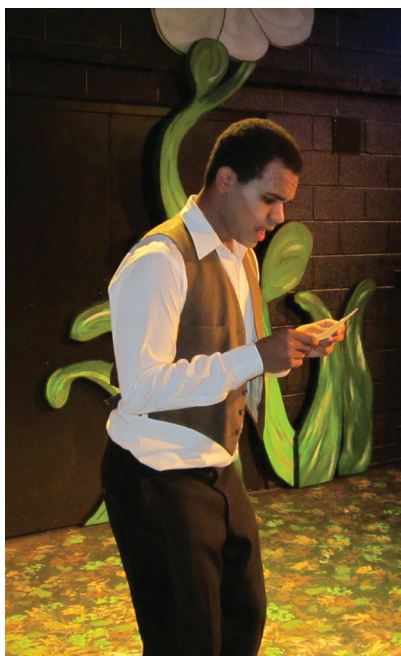
The **LC Theatre** program kicked off the season with "THEATREPALOOZA!", a student and faculty collaboration that began on a Friday night and concluded just 24 hours later in the Johnston Center Meyer Theater with seven original short plays, all written, directed, rehearsed, costumed, and staged by LC Fine Arts students and faculty. These new works were presented in a caffeine-fueled theatre event that showcased the immediacy, flexibility, and potential in theatre. "THEATREPALOOZA!" was such a success, that the Theatre department plans to make it the first show of the season each year.

The second fall production was "Dark of the Moon", written by William Berney and Howard Richardson and directed by Steve Schreiber. **Rhoten, class of 1962.** Dr. Rhoten received the Alumni Achievement Award in 1972 for his achievements in the field of science. Fifty years after his graduation from Lincoln College, Dr. Rhoten has set an amazing example of the success one can achieve when he puts his mind to it. Dr. Rhoten has a B.S. in Zoology from Colorado State University, an M.S. in Zoology from the University of Illinois, a Ph.D. in Anatomy from Pennsylvania

State University (M.S. Hershey Medical Center), and did Postdoctoral work in Experimental Pathology at Washington

University School of Medicine. He has not only learned a great deal from his higher education but he has had many life-changing experiences abroad and in the U.S. He was awarded two Fulbright Senior Scholarships, one to Uganda in 1990 and a second to Zimbabwe in 1996. His service to humankind on a global scale began in 1985 at the University of Cape Town (UCT), South Africa, where he set up a Cell Biology Unit. While in the Faculty of Medicine at UCT he developed and implemented an honors program and had the opportunity to interact and work closely with perhaps the first African students in an honor program in the Department of Anatomy. Dr. Rhoten takes pride in knowing that all those students were successful in receiving their B.Sc. Med. Honours degrees. In 1992, Dr. Rhoten went to Kuwait to provide input into the rebuilding of the Faculty of Medicine after the Iraqi invasion and subsequent liberation by the Coalition Forces. His research investigations included morphological, physiological, biochemical, and molecular biological approaches. These studies focused on various aspects of pancreatic endocrine cell structure and function, comparative endocrinology, and at times the nervous system. This research was funded by NASA, NIH, and other foundations. Currently Dr. Rhoten serves as a half-time Professor of Anatomy in the Department of Biomedical Sciences at Mercer University School of Medicine in Savannah, Georgia. He has earned numerous awards and honors as well as written a number of articles and other publications. Dr. Rhoten has been married to Donna for 43 years, and they have three grown children. Dr. Rhoten shared this reflection, "My experiences abroad led me to develop my creed of 'may we learn how to love one another'."

Much was accomplished during Coach Kaye's tenure, including development of the physical plant, building the varsity room and shower

facilities, and putting the varsity program on a competitive basis with other colleges in the region.

In 1965 Norm went to Chicago and joined Mayor Daley's Poverty Program. This program placed special people in troubled schools in an effort to get the school back into an orderly academic institution. By 1966, Coach Kaye was asked to come be the Director of Bay Campus Students at the University of South Florida in Tampa (USFT). Also in 1966 and 1967 Norm had the honor of directing two Peace Corp Programs for Venezuela at USFT. In keeping with the busy and athletic lifestyle Coach Kaye was used to, he transitioned from USFT to Saint Leo College (now University) in St. Leo, Fla., for the remainder of his higher education career from 1966-1992. There he served as the first four-year Athletic Director, the first director of student affairs, financial aid director, chairman of physical education (the 2<sup>nd</sup> certified state program in Florida), chairman of the building committee where the Activities Center was dedicated in 1970, baseball coach, basketball coach, founder of the Sunshine State Conference in 1974 and its first conference commissioner and executive director, director of institutional advancement and academic advisor.

Coach Kaye has also had the honor of being a husband, father and devoted grandfather. He currently resides in Bonita Springs, Fla., where he enjoys spending lots of time with his grandkids and soaking up the Florida sunshine! Coach Kaye is very excited to return to the Lincoln Campus to celebrate the 50<sup>th</sup> anniversary of the record breaking 1962 Lynx basketball team and their trip to Nationals.

**Allen Hoffert**, class of 1962, resides in Lincoln, Ill. He retired in 2000 from the Logan County Highway Department. Allen's wife, Odette Turner Hoffert, passed away in November 1997. 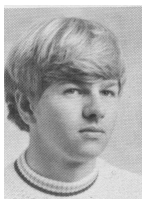
